Subject: - Grant of 2nd Renewal of Permission with Warning to Men-Tsee-Khang (Sowa Rigpa) College, The Dalai Lama Institute of Higher Education, Sheshagirihalli, Bidadi, Hobli, Bengaluru, Karnataka-562109 with 15 seats in UG (BSRMS) course for the academic session 2024-25 under section 29 of NCISM Act, 2020 and relevant regulations thereunder-reg.

Sir/Madam,

With reference to the subject mentioned above, I am directed to inform you that in pursuance of the provision of National commission for Indian System of Medicine Act, 2020, the Indian Medicine Central Council Act,1970 (48 of 1970) has been repealed with effect from the 11th day of June, 2021. With effect from the said date, the Central Council of Indian Medicine constituted under sub-division (1) of section 3 of the Indian Medicine Central Council Act, 1970 (48 of 1970) shall stand dissolved. Now, in exercise of the powers conferred by sub-section (3) of the section 1 of the said Act, the Central Government hereby notifies that all the provisions of the National Commission for Indian System of Medicine Act, 2020 has been come into force with effect from the 11th day of June, 2021 and as per regulation 59 (2) of The National Commission for Indian System of Medicine ACT, 2020, Medical standards, requirements and other provisions of the Indian Medicine Central Council Act, 1970 and the rules and regulations made there under shall continue to be in force and operate till new standards or requirements are specified under this Act or the rules and regulations made there under. Further, the provision of concerned regulations which are inconsistent with the provision of NCISM Act, 2020 shall not be applicable.

1. Further, to assess the available facilities of teaching, non-teaching, hospital staff, practical training and other infrastructure facilities at your college namely **Men-Tsee-Khang (Sowa Rigpa) College, The Dalai Lama Institute of Higher Education, Sheshagirihalli, Bidadi, Hobli, Bengaluru, Karnataka**, inspection of your College was conducted on **18.04.2024 & 19.04.2024 in hybrid mode** as a part of annual visitation by the visitation team of Medical Assessment and Rating Board, NCISM to process the **2nd Renewal of Permission with 15 seats in UG (BSRMS) course under Section 29 of NCISM Act, 2020 for the academic session 2024-25.**
2. Further, the visitation report and all other related documents were assessed in terms of the enforced regulations namely, the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Sowa-Rigpa Colleges and attached Hospitals) Regulations, 2017", provisions under the NCISM Act, 2020 and relevant regulations there under.
3. Thereafter, the assessment report was placed in the **92nd Board meeting** of Medical Assessment and Rating Board for Indian System of Medicine (NCISM) held on **31.05.2024**. On careful examination of the assessment report, it was found that **your college is not fulfilling the notified & approved criteria for issuance of 2nd Renewal of permission with 15 seats in UG (BSRMS) course for the academic session 2024-25** and Board decided to provide an opportunity of hearing to your college. Accordingly, hearing was conducted on **12.06.2024** to present the case through virtual mode.
4. The observation of hearing committee based on the submission made by the college representatives during hearing and assessment report of the NCISM have been carefully re-examined in terms of the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Sow-Rigpa Colleges and attached Hospitals) Regulations, 2017", provisions under the NCISM Act, 2020 and relevant regulations thereunder, and once again, the recommendation of Hearing Committee was placed in the **93rd Board meeting** of Medical Assessment and Rating Board for Indian System of Medicine (NCISM) on **13.06.2024 and 14.06.2024**. Board verified the same and decided to issue **2nd Renewal of Permission with 15 seats in UG (BSRMS) course along with a Warning on certain shortcoming, under section 29 of the NCISM Act, 2020 for the academic session 2024-25.**
5. Therefore, **2nd Renewal of Permission is granted to Men-Tsee-Khang (Sowa Rigpa) College, The Dalai Lama Institute of Higher Education, Sheshagirihalli, Bidadi, Hobli, Bengaluru, Karnataka-562109 with 15 seats in UG (BSRMS) course for the academic session 2024-25 under section 29 of NCISM Act, 2020**

and relevant regulations there under, along with a warning to fulfil the following shortcomings and subject to the condition for the fulfilment of following requirements: -

Shortcomings: -

- a. There is a shortcoming of 1 Peon and 1 Staff nurse in Hospital staffs.

Requirements: -

- i. As per MSE (Sowa-Rigpa) 2022 regulation 4 (4) the counselling for admission to Bachelor of Sowa-Rigpa Medicine and Surgery Programme shall be conducted by Sowa-Rigpa Central Counselling Committee (SRCCC) constituted by the National Commission for Indian System of Medicine in this behalf and in this process the policy on reservation of the concerned state (if any) in the admission of Sowa-Rigpa undergraduate Programme shall be considered.
6. Admissions made in violation of the above conditions will be treated as invalid and action will be initiated under NCISM Act & Regulations thereunder.
7. Further, **as per Sub-section (7) of Section 29 of NCISM Act, 2020**, the Medical Assessment and Rating Board for Indian System of Medicine may conduct evaluation and assessment of any University or medical institution at any time, either directly or through any other expert, having integrity and experience in medical profession, without any prior notice and assess and evaluate the performance, standards and benchmarks of such University or medical institution and if the college is found to be not maintaining the Minimum Essential standards as specified in the concerned Acts & Regulations then **in accordance of Section 28 (1) (f) of NCISM Act, 2020 the issued permission of the college shall deemed to be withdrawn and denial of permission shall be issued by MARBISM for stoppage of admission for that particular or the subsequent academic year.**
8. Discrepancies, if any, may be immediately brought to the notice of Medical Assessment and Rating Board for Indian System of Medicine, NCISM.
9. **The following requirements should be fulfilled by the college by 31st December, 2024 and compliance report should be sent to get permission for the academic session 2025-2026:**
- i) All the requirements under the provisions of the NCISM Act, 2020 and relevant Regulations made thereunder should be fulfilled in toto;
- ii) All the requirements of minimum standard of infrastructure and teaching & training facilities as specified in MES (Assessment & Rating for Undergraduate Sowa-Rigpa Colleges and Attached Teaching Hospitals) Regulations, 2023.
- iii) All the requirements of the Indian Medicine Central Council (Minimum Standards of Education in Indian Medicine) Amendment Regulations, 2022 (for Sowa-Rigpa); and
- iv) The shortcoming mentioned in Para no. 5 above, should be fulfilled.
10. The fulfilment of the conditions given above may be made within the time period specified and compliance report should be submitted by the college to President, Medical Assessment and Rating Board for Indian System of Medicine. The Medical Assessment and Rating Board for Indian System of Medicine will verify that the conditions have been fulfilled for considering the permission for the academic session 2025-26.
