Subject:-Grant of conditional permission to Men-Tsee-Khang (Sowa Rigpa) College, Bengaluru, Karnataka-562109 with 15 seats in UG (BSRMS) course, under section 28 of the NCISM Act, 2020 for the academic session 2023-24.

Sir/Madam,

With reference to the subject mentioned above, I am directed to inform you that in pursuance of the provision of National commission for Indian System of Medicine Act, 2020, the Indian Medicine Central Council Act, 1970 (48 of 1970) has been repealed with effect from the 11th day of June, 2021. With effect from the said date, the Central Council of Indian Medicine constituted under sub-division (1) of section 3 of the Indian Medicine Central Council Act, 1970 (48 of 1970) shall stand dissolved. Now, in exercise of the powers conferred by sub-section (3) of the section 1 of the said Act, the Central Government hereby notifies that all the provisions of the National Commission for Indian System of Medicine Act, 2020 has been come into force with effect from the 11th day of June, 2021.

1. Further, to assess the available facilities of teaching, non-teaching, Hospital staff, practical training and other infrastructure facilities at your college namely **Men-Tsee-Khang (Sowa Rigpa) College, Bengaluru, Karnataka-562109** inspection of your College was conducted **on 02.05.2023 – 03.05.2023 on Hybrid mode as a part of annual visitation by the visitation team of Medical Assessment and rating Board, NCISM to process the Conditional Permission with 15 seats in UG (BSRMS) course for the academic session 2023-24 under Section 28 of NCISM ACT 2020 and relevant regulations thereunder.**
2. Further, in view of above, the visitation report and all other related documents were assessed in terms of enforced regulation namely, the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Sowa-Rigpa Colleges and attached Hospitals) Regulations, 2017", and provisions under the NCISM Act, 2020 and relevant Regulations there under. On examining the case in light of above notified and approved criteria and on perusal of the visitation report, it was observed that the college was not fulfilling the basic eligibility criteria due to following shortcomings:-

The Shortcomings are as under:-

1. Hospital Staff:-

- a. Availability of Hospital Staff is 9 against the minimum requirement of 19 (excluding excess). Percentage of available hospital staff is 47.36%.

3. In view of above, the assessment report was placed in the **46th Board meeting** of Medical Assessment and Rating Board for Indian System of Medicine (NCISM) on **07.07.2023**. On careful examination of the assessment report, considering the deficiencies observed therein as mentioned above the college was given an opportunity of virtual hearing vide the MARBISM letter (Hearing notice) of **even no. dated 02.05.2023** to appear on **03.05.2023** before the designated Hearing Committee to present their case and to show cause as to **why not the conditional permission to your college with 15 seats in UG (BSRMS) course under section 28 of NCISM Act 2020 be denied for the Academic Year 2023-24**. The college was directed to make written submission in respect of the case and produce all relevant valid documents/records/proof against all the deficiencies/shortcomings as indicated above. The representatives of the college submitted written submissions **vide letter MTK/23-24/14 dated 17/07/2023** against the deficiencies conveyed to them.

4. Whereas, the college through its representatives, **Dr. Tenzin Yeshi (Registrar), Dr. Ngawang Jinpa Sunang (Vice Principal)** appeared before the Hearing Committee on **20.07.2023** and made their submission virtually as well as written submission against the shortcomings communicated to the college. The shortcomings communicated to the college; submission made by the representatives of the Sowa-Rigpa college and observations made by the Hearing Committee are as under:-

Pharmacy and Pharmaceutical sciences subject will be part of 2nd Professional syllabus, we couldn't appoint a one so far.

The misunderstanding on the point by the college was cleared by the hearing committee. The college assured that a new tab for the clinical material in the website will be added as a chart. Post hearing itself the committee found that the tab was introduced with the clinical material chart.

3. Observation By The Visitors:-

- Duty Roster - Not available for Technical and other staffs.
- Hospital registration: Under process.
- Fire safety NOC: Under process.

3. Observation By The Visitors:-

(a) Duty Roster:-

Duty roster for the teaching and hospital staff has been verified by the Field visitors. Duty roster for Technical and other staffs not asked as their routine and responsibilities would be same on every working day. Therefore, no separate duty roster has been issued thus far.

(b) Hospital registration:-

College's Principal has met the officers in the state board last year to request the inclusion of Sowa-Rigpa system of medicine in the Karnataka, Private Medical Establishment (KPME) act as their official website has no Registration process for Sowa Rigna thus our college hospital is facing problem in registration. However, College's principal is seeking an appointment with newly appointed honorable Shri. DINESH GUNDU RAO (Health Minister of Karnataka state) to raise issue related with our college such as hospital registration, fire safety, etc as our college is the only Sows-Rigpa College in the state.

(c) Fire safety NOC:-

Under process due to delayed of the inspection from the Fire department. Department officer has responded that final inspection to our college for instalment of fire safety equipment will be carried out after the state election which was

3. Observation By The Visitors:

a) **Duty Roster-** The college submitted that they will maintain duty roster for non-teaching staff within a week.

b) **Hospital registration:** The hospital registration will be under KPME Act, Online registration in the KPME website has to be done for this the Sowa-Rigpa system has to be recognized by the State.

c) **Fire Safety NOC:** Fire Safety NOC will only be considered after hospital registration.

Post hearing submission: request letter for issuance of fire safety NOC is submitted.

1.8 MOU with the nearest modern hospital - SHEERYA HOSPITAL AND LABORATORY was submitted by the college and the MOU is been considered.

Short coming persists

held on 10 May 2023. Still no Meantime, we have installed enough fire extinguishers in each floor of the college and hospital building.

- Building Use/ Occupancy Certificate approved authority: Not Available.

(d) Building Use/Occupancy certificate from local authority:-

College has approached the local panchayat for the procurement of Occupancy certificate which they responded us that now they have no authority to provide such certificate and therefore we would like to submit the building completion certificate, issued by the KHSDRP, Engineering wing of Health and Family Welfare Department. Karnataka State.

d) Building Use/Occupancy certificate from local authority:

The experience of the college authority has been given in the clarification and they repeated it during the hearing orally.

The hearing committee advised the college to acquire a written clarification from the local administration in this regard and also information on whom to approach. If that fails. It is advised they may approach the State AYUSH Ministry itself in this regard.

5. The observation of hearing committee based on the submission made by the college representatives during hearing and assessment report of the NCISM have been carefully re-examined in terms of Regulation 3 of the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Sowa-Rigpa Colleges and attached Hospitals) Regulations, 2017", and provisions under the NCISM Act, 2020 and relevant regulations thereunder, and once again as per the direction of President, Medical Assessment and Rating Board for Indian System of Medicine (NCISM), the recommendation Indian System of Medicine (NCISM) on 27.07.2023.
6. In view of above, the observation of Hearing Committee based on the submission made by the college representatives during hearing and assessment report has been carefully examined in terms of concerned Regulation and provisions under the NCISM Act, 2020 and relevant regulations thereunder, and it was found that the college is not fulfilling the **basic eligibility criteria for issuance of conditional permission for the Academic year 2023-24 due to following short comings:**
 - a. The shortcoming of 7 Hospital staff against the minimum requirement as per MSR Sowa- Rigpa 2017 of 19 (excluding excess).
 - b. The details not uploaded in the website as per as per MSR Sowa- Rigpa 2017.
 - c. Duty Roster for Technical and other staffs as per MSR Sowa- Rigpa 2017.
 - d. Hospital registration.
 - e. Fire safety No Objection Certificate
 - f. Building Use/ Occupancy Certificate approved by concerned authority.
7. **However, Board decided to issue warning in accordance of section 28 (1) (f) of NCISM Act 2020 and grant conditional permission to Men-Tsee-Khang (Sowa Rigpa) College, Bengaluru, Karnataka-562109 with 15 seats in UG (BSRMS) course under section 28 of NCISM Act 2020 for mentioned in above paras by 31st December 2023 as under -**
 - a. Hospital staff shall be as per MSR Sowa- Rigpa 2017.
 - b. Website shall be updated as per MSR Sowa- Rigpa 2017.
 - c. Duty Roster for Technical and other staffs should be available as per MSR Sowa- Rigpa 2017.
 - d. Hospital registration, Fire safety No Objection Certificate, Building Use/ Occupancy Certificate from the concerned Board.
8. Therefore, **Conditional Permission is granted to Men-Tsee-Khang (Sowa Rigpa) College, Bengaluru, Karnataka-562109 with 15 seats in UG (BSRMS) under section 28 of NCISM Act, 2020 and relevant regulations there under for the academic session 2023-24 subject to the condition that college is also fulfill the following requirement-**
 - i. As per MSE (Sowa-Rigpa) 2022 regulation 4 (4) the counselling for admission to Bachelor of Sowa-Rigpa Medicine and Surgery Programme shall be conducted by Sowa-Rigpa Central Counselling Committee (SRCCC) constituted by the National Commission for Indian System of Medicine in this behalf and in this process the policy on reservation of the concerned state (if any) in the admission of Sowa-Rigpa under-graduate Programme shall be considered.
 - ii. Admissions made in violation of the above conditions will be treated as invalid and action will be initiated under NCISM Act & Regulations thereunder.

9. Discrepancies, if any, may be immediately brought to the notice of Medical Assessment and Rating Board for Indian System of Medicine, NCISM.
10. The following requirements should be fulfilled by the college by 31st December, 2023 **and send a compliance report to get permission for the academic session 2024-25:**
 - (i) All the requirements of Minimum Standard of infrastructure and teaching & training facilities as specified in Regulation 3 of the "Indian Medicine Central Council (Requirements of Minimum Standard for undergraduate Sowa-Rigpa Colleges and attached Hospitals) Regulations, 2017;
 - (ii) All the requirements of the Indian Medicine Central Council (Minimum Standards of Education in Indian Medicine) Amendment Regulations, 2017 (for Sowa-Rigpa);
 - (iii) all the requirements under the provisions of the NCISM Act, 2020 and relevant Regulations made thereunder should be fulfilled in toto;
11. The fulfillment of the conditions given above may be made within the time period specified and compliance report should be submitted by the college to President, Medical Assessment and Rating Board for Indian System of Medicine. The Medical Assessment and Rating Board for Indian System of Medicine will verify that the conditions have been fulfilled for considering the permission for the academic session 2024-25.
